MINUTES OF MEETING MONTGOMERY TOWNSHIP BOARD OF SUPERVISORS April 24, 2017

At 7:00 p.m. Chairman Candyce Fluehr Chimera called to order an executive session.

In attendance were Supervisors Michael J. Fox, Richard E. Miniscalco and Jeffrey W.

McDonnell. Vice Chairman Robert J. Birch was absent. Also in attendance were Township

Manager Lawrence Gregan, Township Solicitor Frank Bartle, Esquire, and Police Chief J. Scott

Bendig.

Chairman Candyce Fluehr Chimera called the meeting to order at 8:00 p.m. In attendance were Supervisors Michael J. Fox, Richard E. Miniscalco and Jeffrey W. McDonnell. Vice Chairman Robert J. Birch was absent. Also in attendance were Township Solicitor Frank Bartle, Esquire, Township Manager Lawrence Gregan, Police Chief Scott Bendig, Director of Finance Ami Tarburton, Director of Administration and Human Resources Ann Shade, Assistant to the Township Manager Stacy Crandell, Director of Planning Bruce Shoupe, Director of Public Works Kevin Costello, Director of Recreation and Community Center Floyd Shaffer, Director of Information Technology Richard Grier, Public Information Coordinator Kelsey McMeans and Recording Secretary Deborah Rivas.

Following the Pledge of Allegiance, Chairman Candyce Fluehr Chimera called for public comment from the audience and there was none.

Solicitor Frank Bartle announced that the Board had met in an Executive Session prior to this meeting to discuss one matter of personnel and one labor matter. The personnel matter was the interview of police officer candidates and the labor matter was a status of police contract negotiations. Mr. Bartle stated that these matters are legitimate subjects of executive session pursuant to Pennsylvania's Sunshine Law.

Chairman Candyce Fluehr Chimera made a motion to approve the minutes of the April 10, 2017 Board of Supervisors meeting, and Supervisor Richard Miniscalco seconded the motion. The minutes of the meeting were unanimously approved as submitted.



Board Chairman Candyce Fluehr Chimera introduced the Odyssey of the Mind Program Participants. The Odyssey of the Mind is an international program that challenges teams of five to seven students to use their creativity and problem-solving skills to solve short-term "spontaneous" problems and a long-term problem that ranges from building mechanical devices to presenting their own interpretation of literary classics. Students learn to work together, to manage their own time, and ultimately to take responsibility for every part of their final solution. At the end of the Odyssey season, teams bring their solutions to competition at a regional level. The Odyssey Program is open to all grades and academic levels under the guidance of adult volunteer coaches. Resolution #1 made by Supervisor Michael J. Fox, seconded by Supervisor Richard Miniscalco and adopted unanimously, recognized the students from the North Penn School District for their outstanding accomplishments in the 2017 Odyssey of the Mind program.

Police Chief Scott Bendig reported the Police Department has been reviewing the traffic ordinances in the Township Code to ensure the information is accurate and up to date.

Township staff recently audited the listing of ordained "Right Turn Prohibited on Red Signal" intersections, comparing it to those intersections that have Right Turn Prohibited signs installed and those permitted by PennDOT. Chief Bendig requested that the Board consider the

approval of proposed Ordinance#17-304, which will ensure that Right Turn Prohibited signs throughout the Township are consistent with Township Ordinances and PennDOT Traffic Signal Permits. Resolution #2 made by Supervisor Michael J. Fox, seconded by Supervisor Jeffrey W. McDonnell and adopted unanimously, adopted Ordinance #17-304- amending Section 222-11 of the Township Code Right Turn Prohibited on Red Signal.

Director of Finance Ami Tarburton presented the 1st Quarter 2017 Budget report. Ms.

Tarburton's presentation summarized the year-to-date operating results through March 31, 2017 and identified the significant activities in the fund balance, revenues and expenses. Ms.

Tarburton reported that overall the Township finances are in excellent condition, with the 1st

Quarter revenues and expenses tracking as expected in the 2017 Budget.

Director of Finance Ami Tarburton reported that several projects and activities have occurred during the first quarter of 2017 that require amendments to the 2017 budget in order to accurately reflect these revenues and expenditures. The proposed amendments include: 1) additional legal fees required to support the Township's participation in the Act 111 Arbitration between the Township and the Montgomery Township Professional Firefighters' Association; 2) the budget for Operating Supplies expense required to maintain and repair Township street lights was inadvertently under-budgeted; and 3) a reduction in the appropriation for the 2017 In-Place Paving Project in the amount of \$204,845 as a result of the bid award. Resolution #3 made by Chairman Candyce Fluehr Chimera, seconded by Supervisor Richard E. Miniscalco and adopted unanimously, approved the 2017 1st Quarter Budget Amendments to the Fire Protection Fund, the Street Light Fund and the Liquid Fuels Fund.

Director of Finance Ami Tarburton reported that new bid limits have been published for 2017 which increase the minimum dollar amount that requires townships to advertise and seek bids for purchases and contracts. The Board of Supervisors acknowledges the State required bidding limits in the 'Montgomery Township Purchasing Policies and Procedures' which governs

Township staff on how to adhere to and process the requirements. This document requires an update to reflect the new limits which are:

Contracts below \$10,700 – no advertising or competitive bidding required; and

Contracts between \$10,700 and \$19,700 – three informal (written, telephonic, electronic)

price quotes are required, with award to the lowest bidder; and

Contracts over \$19,700 – advertising twice and formal competitive bidding is required.

Resolution #4 made by Chairman Candyce Fluehr Chimera, seconded by Supervisor Richard E.

Miniscalco and adopted unanimously, approved the changes to the 'Montgomery Township

Purchasing Policies and Procedures' by increasing the required bid limits to adhere to the

Department of Labor and Industry thresholds for 2017.

Edward J. Furman, CPA, Partner of Maillie, LLP provided an overview of the 2016

Preliminary Audit Results for Montgomery Township. Mr. Furman reported that Montgomery

Township had a solid year for 2016, with an unqualified audit, strong balance sheets and an extremely strong financial report. The complete Comprehensive Audited Financial Report is still being finalized and will be published on the Township's website when completed.

Planning Director Bruce Shoupe reported that surveys were conducted in 2014 and 2015 in major Township park areas of Spring Valley Park, Windlestrae Park, Fellowship Park and the Knapp Road Natural area which identified nearly 750 ash trees on these sites that could potentially be affected by the infestation of the Emerald Ash Borer. This bug is an invasive forest insect from Asia responsible for the deaths of millions of ash trees throughout the eastern half of the U.S. and Canada. Other open space areas in the Township could also have a similar volume of potentially affected trees. The Township Public Works Department has been very active this year cutting down trees throughout the parks and open space areas that have died and pose a potential threat of falling and causing property damage and/or injury. To address this issue, staff is proposing a program to identify high risk trees on Township properties along property lines, trails, roads and sidewalks for removal. A proposal has been received from Curt

Eshleman, Timberlink Consulting, LLC for professional services to assist the Township to identify and mark the high risk trees. When the trees are identified the Township will then hire a contractor through a competitive bidding process to assist the Public Works Department in removing these trees. Supervisor Michael J. Fox requested that the approval of the proposal include a cap or not to exceed price, along with the proposed hourly rate. The not to exceed price was suggested to be \$7,500. After that number is reached, it was recommend that the proposal be reviewed to see how many areas in the Township remained to be checked.

Resolution #5 made by Supervisor Michael J. Fox, seconded by Chairman Candyce Fluehr Chimera and adopted unanimously, accepted the proposal from Curt Eshelman, Certified Forester, Timberlink Consulting LLC, dated April 5, 2017, to perform risk assessment of the ash tree resources located in various areas of the Township's park and open space properties for damage as a result of the Emerald Ash Borer at the hourly rate of \$75.00 per hour, not to exceed \$7,500.00.

Planning Director Bruce Shoupe presented a construction escrow release requested by Maple Brook Estates, LDS#664OHB, as recommended by the Township Engineer. The original amount of the escrow was \$1,018,665.65, held as a Performance Bond. This is the fifth escrow release for this project. The current release is in the amount of \$216,637.82, which would leave a balance of \$151,149.17. Resolution #6, made by Chairman Candyce Fluehr Chimera, seconded by Supervisor Michael J. Fox and adopted unanimously, authorized a construction escrow release in the amount of \$216,637.82, as recommended by the Township Engineer for Maple Brook Estates, LDS#664OHB.

A motion to approve the payment of bills was made by Chairman Candyce Fluehr

Chimera, seconded by Supervisor Richard E. Miniscalco, and adopted unanimously, approved the payment of bills as submitted.

There being no further business to come before the Board, the meeting adjourned at 9:12 p.m.



BACKGROUND:

In honor of Police Week, the Police Department would like to recognize several members of the law enforcement community for their outstanding performance in the line of duty as recommended by the Police Department's Award Committee. This Committee, appointed by the Chief of Police, considers those cases of outstanding police performances as nominated by the officer's supervisor.

Letter of Official Commendation-Officer James Matlack, Officer Jeff DePolo, Officer Taylor Jones, Detective Todd Walter, Montgomery County Detective Paul Bradbury, Montgomery County Detective Edward Schikel, Assistant District Attorney Laura Bradbury, and Assistant District Attorney Kristen Feden:

On April 24, 2016, Officer James Matlack, Officer Jeff DePolo, and Officer Taylor Jones of the Montgomery Township Police Department responded to the Keystone Fellowship Church on Stump Road for an active shooter incident during a church service with approximately 250 attendees. Arriving officers discovered that congregation member Robert Braxton III had been shot by congregation member Mark Storms during the service. Officers assisted in rendering medical aid to the victim, detained the shooter, and began the initial investigation, identifying witnesses. Montgomery County District Attorney's Office Detective Paul Bradbury and Montgomery Township Detective Todd Walter arrived on scene, serving as the lead investigative team, while Montgomery County District Attorney's Office Detective Edward Schikel processed the crime scene at the church. Tragically, Mr. Braxton succumbed to his injuries. After a lengthy investigation Mark Storms was arrested and charged with Voluntary Manslaughter and Reckless Endangerment, Montgomery County Assistant District Attorneys Laura Bradbury and Kristen Feden led the prosecution of Mark Storms, culminating with a guilty verdict on all counts. On April 18, 2017, Mark Storms was sentenced to 10 to 20 years state prison.

Letter of Official Commendation-Corporal Thomas Ward, Officer Brian Gerrard, and Officer Peter Byrne:

On April 30, 2016, Corporal Thomas Ward, Officer Brian Gerrard, and Officer Peter Byrne responded to a home on Blue Ribbon Drive for an unresponsive subject. Officers arrived on scene and found the patient not breathing with no pulse. CPR was initiated on the patient. While performing CPR, officers learned that the individual may have ingested opioids. Officers administered Naloxone to counteract the opioids. The patient was stabilized by members of the Volunteer Medical Service Corps of Lansdale and transported to Abington Hospital-Lansdale where he fully recovered.

Letter of Official Commendation-Officer Timothy Woch

On November 5, 2015, Officer Woch responded to Abington Hospital-Main for an assault. The victim, who resided in Montgomery Township, had sustained serious injuries to her face, including several broken teeth. During an interview the victim was uncooperative, stating that her injuries resulted after she struck

a tree. Several interviews were conducted with associated individuals. A comprehensive canvas of the victim's neighborhood was conducted, resulting in the discovery of additional evidence. The victim's boyfriend was subsequently charged with aggravated assault and related charges under the domestic violence statute. On August 10, 2016, the defendant was found guilty of simple assault and harassment.

Official Commendation for Life Saving-Officer Andrew Dalton and Officer Michael Jenkins:

On March 26, 2017, Officer Andrew Dalton and Officer Michael Jenkins responded to Brookside Assisted Living Facility for a resident who was choking. Officers arrived on scene and found that the patient, who was now unconscious, was not breathing and had no pulse. Officers initiated and continued to perform CPR until the patient was stabilized by members of the Volunteer Medical Service Corps of Lansdale and transported to Abington Hospital-Lansdale. The patient has since recovered.

Official Certificate of Commendation-Corporal Thomas Ward

On December 1, 2016, Corporal Thomas Ward stopped a vehicle on Knapp Road for several equipment violations. During Corporal Ward's interaction with the driver he noted his nervous behavior, evasive answers to questions, and conflicting statements. Written consent to search the vehicle was requested from and granted by the driver. A search of the vehicle produced 192 bags of heroin, Oxycodone, Alprazolam, marijuana, Phencyclidine (PCP), crack cocaine, and packaging material related to drug sales. Through further investigation, Corporal Ward was able to ascertain that the driver was staying at a local motel. Written consent to search the room was requested from and granted by the driver. A search of the room produced a Kel-Tec P11 9mm handgun which was later found to have been reported stolen in Norristown, PA. An additional 60 grams of heroin was also found in the room. During the investigation, it was determined that the driver rented a storage locker in Norristown as well. Written consent to search the locker was requested from and granted by the driver. This search produced an illegally altered shotgun, drug paraphernalia, and ammunition. The driver was arrested for firearms violations, violations of the Drug Act, including possession with the intent to deliver.

Official Commendation for Heroism- Officer Andrew Dalton, Officer Michael Jenkins, and Officer John Rushin

On November 26, 2016, Officer Andrew Dalton, Officer Michael Jenkins, and Officer John Rushin responded to a home on Signal Hill Court for a report of an armed subject in the home. Officers were advised that the caller's father was intoxicated and was aiming a handgun at family inside. Upon arrival, officers met with the caller outside who stated that her father had a gun and was going to kill her family. Officers immediately entered the home since family members were still inside. Officers found the father armed with a handgun struggling with his son on a staircase. Officers were able to physically disarm the father and take him into custody. No one in the home was harmed. The father was charged with violations of the Firearms Act, assault, and related offenses.

Dear Administrator:

Every three years, Montgomery County is required to identify those municipalities that wish to participate in the County's Community Development Block Grant Program. The purpose of this process is to establish the Urban County's population base in order to calculate the amount of funding we will receive from the U. S. Department of Housing and Urban Development.

The purpose of this notice is to identify those municipalities that wish to participate in the Urban County CDBG Program for the program periods 2018 through 2020 inclusive. Participation in the program will make your municipality eligible for funding.

To assist us in this process, please follow these instructions:

Option A: Opt in Status

This option qualifies you to participate in the Urban County program and makes you eligible for funding through September 30, 2020. If you choose to remain with Montgomery County, you are ineligible to apply for grants under the State CDBG programs while you are part of the urban county. In becoming a part of the urban county, you automatically participate in the HOME and ESG programs if the urban county receives HOME and ESG funding, respectively. Moreover, while units of general local government may only receive a formula allocation under the HOME and ESG programs as part of the urban county, this does not preclude the urban county or a unit of government participating with the urban county from applying for HOME or ESG funds from the State, if the State allows.

If you choose this option, no action is necessary.

Option B: Opt out Status

This option means you will be excluded from participation in the Urban County program and cannot receive CDBG/HOME/ESG funds for the next three years. However, you would be eligible to participate in the Commonwealth's Small Communities Program. Under this program,

administered by the State Department of Commerce and Economic Development, you would compete for CDBG funds with other communities across the State.

If you choose this option, you <u>must</u> notify in <u>writing</u> both Montgomery County and the HUD Regional Office. Such election to be excluded will be effective for the entire three-year period, unless you specifically elect to be included in a subsequent year for the remainder of the County's three-year qualification period. Per your request, I have reviewed the current Montgomery Township landscape material fee-inlieu schedule and compared the existing fees to recent cost amounts for installed plant material in the vicinity of Montgomery Township.

Costs have increased significantly in recent years due to shortages of high-demand sizes of plant material as a result of nursery downsizing during the recent recession. For my analysis, I looked at recent bids for landscape projects, historical cost data on PennBid, and available nursery cost schedules. When looking at nursery cost data, I included in an installation factor of 50% of the plant cost. When adding the installation factor to the nursery price, the totals were generally consistent with bid data and historical cost data from PennBid.

The current Montgomery Township landscape fee schedule includes two line items: \$350 per tree for trees 2.5-3.25" caliper, and \$65 per shrub. In light of recent revisions to the landscape portion of the SLDO which now permits a wider range of tree sizes, I recommend that the following fee-in-lieu amounts be implemented.

Shade Trees 3" min. caliper, 14-16' in height: \$600 Shade Trees 2" min. caliper, 12-14' height: \$450 Replacement Shade Trees 2.5" min. caliper: \$500

Evergreen Trees 8-10' min. height: \$550

Ornamental/Flowering Trees 1.25" min. caliper, 8-10' height: \$400

Deciduous and Evergreen Shrubs: \$90

BACKGROUND:
