## **MONTGOMERY TOWNSHIP SNOW REGULATIONS**

### **SNOW AND ICE EMERGENCY**

- After a snow emergency is declared, it shall be unlawful at any time during the continuance of the emergency for any person to park a motor vehicle or to allow that vehicle to remain parked anywhere on the snow emergency route.
- If at any time during a period of snow emergency a person parks a motor vehicle or allows a motor vehicle to remain parked anywhere upon a snow emergency route the person can be fined.
- Motor vehicles may be removed from the road if they are found to be hindering regular traffic or snowplowing/ salting operations. The vehicle owner is responsible for the fines, towing and storage fees incurred.

### **SNOW REMOVAL**

- Within 24 hours after snow has stopped falling a pathway on the sidewalk shall be cleared on respective properties or sidewalks on land abutting their property.
- Snow removal must be placed on person's property, NOT THE STREET.
- Snow should not be piled around or on a fire hydrant.
