

**MONTGOMERY TOWNSHIP SENIOR VOLUNTEER COMMITTEE**  
**MEETING MINUTES**  
**June 8, 2010**

The reorganization meeting and regular monthly meeting of the Montgomery Township Senior Volunteer Committee was held at 7:00 p.m., Wednesday, June 8, 2010 at the Montgomery Township Building. **Call to Order:** Chairman Ralph Schurr called the meeting to order at 7:05PM.

**New Business:**

**Meeting with Speaker for Long-Term Care Insurance Presentation- Frank W. Crandell, Jr.**

The Committee Members met with Frank Crandell regarding a new seminar about long-term care insurance. Mr. Crandell presented some background on himself and his experience in long-term care insurance and financial advising. He also presented a packet for each of the members that he will provide at the seminar and he may have an additional speaker, Tim Kelly, who also has an extensive experience in long-term care insurance.
