## **June 2018 Regular Monthly Meeting**

### **CALL TO ORDER**

Vice-Chair Meehan Brooks called the June meeting to order at 7:35pm.

### **APPROVAL OF MINUTES**

Mr. Quasti made a motion to approve the May 9th, 2018 minutes and Mr. Grasso seconded the motion. The approval was unanimous.

### **PARK ACTIVITY/PUBLIC WORKS UPDATE**

Mr. Reiff discuss several Eagle Scout projects that are being completed in the Parks.

- 2) Eagle Scouts have repaired Walking bridges along the trail system.

Tennis court resurfacing is underway at the Rose Twig courts.

Removal of Ash trees continues at Zehr. Mr. Reiff stated that the tree removal project in quite large and extensive.

## **NEW BUSINESS / OLD BUSINESS**

### **Disc Golf**

Township resident, Mr. Chuck Vesay with the assistance of resident Chuck Ziegler, presented an updated diagram for a “senior friendly” Disc Golf tract that included yardages for the nine hole layout. The proposed course goes around the cornfield area of the Henning’s tract and does not appear to infringe on the cornfield itself. Mr. Vesay also provided a draft of possible rules and regulations for the course.

The Board discussed the proposal and on a motion by Mr. Quasti and a second by Mr. Grasso decided to cancel the July 2018 monthly Meeting. The motion carried unanimously.

Instead of the monthly meeting the Park Board will meet in the Henning Field area of Windlestrae to walk the Mr. Vesey’s proposed disc golf layout and ultimately make a recommendation to the Board of Supervisors.
