



**Montgomery Township
Park and Recreation Board
Meeting Minutes October 10th, 2018**

October 2018 Regular Monthly Meeting

CALL TO ORDER

Chairperson Brooks called the October meeting to order at 7:32pm.

APPROVAL OF MINUTES

Mr. Quasti made a motion to approve the May 9th, 2018 minutes and Ms. Greene seconded the motion. The approval was unanimous.

PUBLIC COMMENT

There was no public comment.

PARK ACTIVITY

Kim Greene initiated a continuation of the discussion regarding the relocation of the Bark Park in Montgomery Township. While there was theoretical discussion of relocating it closer to Route 202, the feeling of the board was that the Bark Park being located close to a pedestrian walkway would not be ideal for either the Bark Park patrons or the pedestrians. At this time, no further locations were proposed. It was suggested that board members continue to explore the dog park amenities in nearby Townships.

It was also discussed that trees were down in Rose Twig. This is part of the continuing Ash Tree removal.

PUBLIC WORKS UPDATE

Mr. Reiff reported on the following:

- 1) There is a plan to work on the tennis courts at Fellowship Park.
- 2) There is a plan to fix the Windlestrae Park Driveway off Kenas Road.

3) Public works is continuing their ongoing project of Ash Tree removal.
