<u>Korean War Memorial Update</u> – The bid for the hardscaping was awarded in the amount of \$366,000. The Township contact three contractors for the landscaping portion of the project and received one quote. The landscaping contract was awarded to Holly Days Nursery in the amount of \$5,795 and is scheduled to be installed the end of November after the hardscaping is completed.
