  - The Committee are looking to see what the additional cost will be to hire staffing from the attraction-supplying company, should The Committee need to do so.
  - The Committee have decided to not bring back the attraction called "Spider Mountain"

### • Vendors/Sponsors

o No changes were made to the sponsorship levels for 2019.

### Food Concessions

- o Ms. Alfarano offered to share a list of certified food truck vendors via email with the Committee and Township liaisons.
- o Suggestions included Jesse's BBQ & the new Dunkin Donuts location.

### • Transportation

o No discussion revolving around transportation was had.

## • Entertainment/Demonstrations

- The Committee would like to pursue developing two main attraction areas: the Kiddie Korner and the Tween/Adult area
  - Proposed site for Tween/Adult area –field next to food concessions
- o Mr. Northrop will reach out to the ROTC regarding a portable rock wall for the event.

# • Crafts/Activities

o To better facilitate the pumpkin distribution, a sign with procedures will be posted.

- The pumpkin station point person will also have a megaphone to help communicate procedures with the public.
- o Staff & Volunteers are not to hold pumpkins for anyone.
- We will reach out to our sponsors, and aim to gain more sponsorship, to help staff the attractions safely in exchange for increased publicity via signs at the sponsored attraction(s)
- o Face painting options were discussed.

 A brainstorm session was held during the meeting, and a list was compiled of organizations and businesses to reach out to for volunteers.

There being no further business, on a motion by Mr. Northrop and a second by Mr. Wood, the meeting was adjourned at 6:15pm.
