3. CORRESPONDENCE:

Supervisor Long received an inquiry from Mr. Long regarding dumping, drainage, and stump removal issues at Hourglass Park. Director Reiff advised that they were working on these concerns, adding that the stump removal issue resulted from the ash tree removal project. The removal of these stumps has been added to the list for removal.

4. OLD BUSINESS:

At the October 20, 2021 Meeting, resident Michael Stachowicz requested a streetlight on the corner of Greys Lane and Pioneer Spur. Mr. Stachowicz stated that the

intersection is dark at night, and he would like a streetlight to enhance safety and lighting. An analysis was conducted by the Police Department's Highway Safety Unit. This examination included:

- Review of the original development plan submitted to the Township
- Examination of crash data
- Site distance review
- Review of current ambient lighting conditions at darkness
- Vetting at the Township Traffic Engineers Meeting
- Speed study of Grays Lane

After the above analysis, it was determined that an additional street light is not recommended. Mr. Stachowicz was advised of the findings.
