MONTGOMERY TOWNSHIP PLANNING COMMISSION

January 6, 2011

The January 6, 2011, meeting of the Montgomery Township Planning Commission was called to order by Chairman Jonathan Trump at 7:30 p.m. In attendance were Commissioners Michael Beatty, Jay Glickman, James Rall and Ellen Reynolds. Commissioners Leon Mc Guire and Eric Phillips were absent. Also present was Larry Gregan, Township Manager.

The minutes of October 7, 2010, were approved as submitted.

The only item on the agenda was reorganization. Vice-Chairman Jay Glickman opened nominations for Chairman. Mr. Rall nominated Jonathan Trump. There were no other nominations. Mr. Rall made a motion, seconded by Ms. Reynolds, to appoint Jonathan Trump as Chairman. Motion carried unanimously 5-0. Mr. Rall nominated Jay Glickman as Vice-Chairman. There were no other nominations. A motion was made by Mr. Rall, seconded by Ms. Reynolds, to appoint Jay Glickman as Vice-Chairman. Motion carried unanimously 5-0. Nominations for Secretary were opened. Mr. Rall nominated Ellen Reynolds as Secretary. There were no other nominations. Mr. Rall made a motion to appoint Ellen Reynolds as Secretary. The motion was seconded by Mr. Glickman and carried unanimously 5-0.

After some discussion, it was decided that meetings would be advertised for two meetings per month; however, this would be evaluated each month to see if both meetings would be necessary. It was decided that the third Thursday of each month would be the preferred meeting date if two meetings were not necessary. Also noted was that in April and September there would only be one meeting per month, April 7 and September 15, due to holidays. Also discussed was the assignment of coverage for the Supervisors' meetings. These lists are attached to these minutes.

Under public comments, residents who were in attendance, questioned as to the status of the hearing for the Joseph Ambler Inn. It was discovered that they were at the wrong meeting. This was a Zoning Hearing Board application. Mr. Gregan updated them on the outcome of that meeting.

This meeting was adjourned at 8:10 p.m.

The next meeting of the Planning Commission will be held on Thursday, January 20, 2011.
