The monthly meeting of the Montgomery Township Environmental Advisory Committee (EAC) was held on January 27, 2015 in the Montgomery Township Municipal Building. Old Business

Bike Trail/Walking Routes Project Presentation

Christy Staudt and Ben Guthrie, from Traffic Planning & Design, Inc. (TPD) attended the meeting to give a presentation on the bike trail/walking routes study they were working on the past several months. Their presentation covered various methods of adding a bike lane to roadways such as buffered bike lanes, side paths and paved shoulders. Christy and Ben shared an implementation plan with several possible connections throughout the Township

to connect to the parks and to retail shopping areas. They also reviewed several different funding options the Township can look into.

Christy and Ben will send an electronic version of the maps or possible hard copies of the maps so the Committee can provide feedback. Once feedback is received, they will review the implementation plan and provide a list of priorities with estimated costs so the Committee can make recommendations to the Board of Supervisors on how to proceed with this plan.
