### **Old Business:**

<u>Copper Beech at CRC</u> - Montgomery Gardens will coordinate with Gilmore Associates for the installation and inspections. The 105" spade has been repaired and they are now able to dig and plant the tree this summer. Due to the excessive heat and rain, the planting has been postponed. It is currently scheduled for August 23<sup>rd</sup>. John Antonucci will donate a boulder to be placed near the tree for the dedication plaque to be mounted on. The Commission is looking to purchase a 12x18 bronze plaque to dedicate the tree's planting to commemorate the Township's 300<sup>th</sup> Anniversary

<u>Welcome to Township Monuments</u> – The project will be added to the 2022 budget. The Commission is looking to match the monument / fencing installed at the entrance of Enclave Blvd at Bethlehem Pike. Once we estimates, we can determine the proposed locations.

<u>2021 Community Forestry Workshop</u> – The agenda and speakers topics and information are being finalized. Waiting to confirm with the PA Department of Agriculture as to availability of a representative to present the PA Pesticide Regulatory Update.
