4. OLD BUSINESS:

School Bus Crash on December 19, 2018:

Chief Bendig addressed a previous concern of the committee regarding a pedestrian crash involving school-age children on December 19, 2018. Chief Bendig spoke with North Penn School District's Safe Schools Coordinator regarding school bus driver protocols and incidents involving students waiting at bus stops. There is no formal policy regarding the steps to be taken other than the driver contact the bus dispatcher to call 911 should a driver encounter a similar type incident. Driers are given the discretion regarding disembarking their bus to assist others at such an incident based on the age and maturity level of the student being transported.

<u>VMSC Response to a Call for Service at LA Fitness on October 22, 2018 and Recognition of Citizens for Lifesaving Acts of Service:</u>

Sue Weiner raised questions regarding the the time it took an ambulance to arrive as well as the protocol by ambulance personnel upon arrival. These matters were researched by the Chief of VMSC. The Chiefs findings were presented by Rick Vetri, President of VMSC. Further discussion to follow at the next Public Safety Meeting.

Chief Bendig reported that the Chief of VMSC did recommend that those citizens involved in this incident be recognized for their lifesaving actions based on an

analysis of the AED used at the scene. Chief Bendig advised that the American Red Cross and American Heart Association will recognize citizens for such acts. Supervisor Bamford requested that Chief Bendig submit those citizens for a Certificate of Merit award by the American Red Cross.
