**MINUTES OF MEETING
MONTGOMERY TOWNSHIP BOARD OF SUPERVISORS
JUNE 24, 2013**

Chairman Joseph Walsh called the action meeting to order at 8:00 p.m. In attendance were Supervisors Robert Birch, Candyce Fluehr Chimera, Michael Fox and Jeffrey McDonnell. Also in attendance were Frank Bartle, Esquire, Lawrence Gregan, Chief J. Scott Bendig, Richard Lesniak, Kevin Costello, Bruce Shoupe, Shannon Drosnock, Ann Shade, Richard Grier and Deb Rivas.

Following the Pledge of Allegiance, Chairman Joseph Walsh called for public comment from the audience and there was none.

Chairman Joseph Walsh made a motion to approve the minutes of the June 10, 2013 Board meeting, and Supervisor Michael Fox seconded the motion. The minutes of the meeting were unanimously approved as submitted.

Chairman Joseph Walsh noted that Montgomery Township is filled with many talented residents and the Board would like to honor students of Montgomery Township for their outstanding academic and athletic achievements. Jacqueline James is a graduating senior from Mount St. Joseph's Academy where she rowed on the Mount's "Two-Vee" boat which won the gold medal at the 2013 Stotesbury Cup Regatta. Ms. James was also named a National Merit Finalist and will be attending Villanova University on a Presidential Scholarship where she will continue her education pursuits in addition to pursuing her interest in rowing on the crew team.

Katie Mirabella is a graduating senior from Mount St. Joseph Academy, where she also rowed on the Mount's lightweight eight which won a three-way battle for second place at the 2013 Stotesbury Cup Regatta. Ms. Mirabella was named a National Merit Finalist and is an AP Scholar. She will be attending Princeton University where she will continue her educational pursuits in addition to pursuing her interest in rowing on the crew team.

Mr. Walsh noted that many Township resident students participate in the Odyssey of the Mind international program which challenges teams of five to seven students to use their creativity and problem-solving skills to solve short-term "spontaneous" problems and a long-term problem that ranges from building mechanical devices to presenting their own interpretation of literary classics. Mary Mother of the Redeemer School had three teams which succeeded in earning significant placements in regional, state and finals levels. The students from the Mary Mother of the Redeemer teams introduced themselves and described their team's challenge. The students from Mary Mother of the Redeemer who participated in the Odyssey of the Mind challenge were Julia Capreri, Julia Coakley, Connor Donohue, Nolan Dougherty, Nathaniel Ensanian, Mairin Higgins, Jessica Howard, Rachel Kalkbrenner, Molly Keel, Christopher Kelm, Jacob Lambert, Alexandra Lyons, Michael O'Donnell, Nicholas Orlando, Jack Pilewski, Hannah Soisson, Reanne Bull, Joseph Howard and Matthew Becker.

Pennbrook Middle School's Odyssey of the Mind team competed at the state level and placed fifth in their category. The students from the Pennbrook Team introduced themselves. The Pennbrook students who participated were Amy Cook, Molly DiPlacido, Anastasia Dziekan, Shannon Guerin, Andrew Jia, Cynthia Martinez and Brenna Ryabin.

The students and teams were presented with Certificates of Achievement from the Board of Supervisors and congratulated for their outstanding academic and athletic achievements.

Connor Donohue, a fourth grade student from Mary Mother of the Redeemer, was recognized for his outstanding achievements in the Continental Math League. Also, Alexandra Lombardi, a sixth grade student from Mary Mother of the Redeemer, was recognized for her Youth Essay of Merit Award for her Patriot's Pen submission, "What Would You Say to the Founding Fathers Today?" The contest was sponsored by the VFW Post 6493.

Police Chief Scott Bendig announced that Police Sergeant Thomas J. Dunlap would be retiring from the Montgomery Township Police Department after 40 years of service to the community. Sgt. Dunlap began his career with the Montgomery Township Police Department as a Police Cadet on December 1, 1973. Sgt. Dunlap was elevated to Full Patrolman in 1977, promoted to Corporal in 1984, becoming a founding member of the Township's first Traffic Safety Unit, and promoted to Sergeant in 1987. Sgt. Dunlap has since then served as a squad supervisor, planning, organizing and directing the activities of officers assigned to his platoon. Sgt. Dunlap has received numerous commendations and letters of appreciation from residents and neighboring agencies. A representative from Pennsylvania State Representative Todd Stephens office presented proclamations from the Pennsylvania House of Representatives congratulating and commending Sgt. Dunlap on his retirement and thanking him for his service to the community. Resolution #1, made by Supervisor Michael Fox, seconded by Supervisor Robert Birch and adopted unanimously, recognized Sergeant Thomas Dunlap and expressed their gratitude to him for his dedication and faithful service to the Montgomery Township Police Department and the residents of our community.

Director of Public Works Director Kevin Costello introduced Public Works employee, Greg Reiff, who is being promoted to the position of Park Foreman, effective June 24, 2013. Mr. Reiff began his career with Montgomery Township in May of 2000 as a Laborer and quickly worked his way up to Crew Tech II. In April of 2011, Mr. Reiff was promoted to the position of Assistant Park Foreman. The Board thanked Mr. Reiff for his dedication and congratulated him on his promotion. Resolution #2, made by Chairman Joseph Walsh, seconded by Supervisor Michael Fox and adopted unanimously, recognized the promotion of Greg Reiff to the position of Park Foreman in the Public Works Department.

Director of Public Works Kevin Costello reported that the Public Works Department is requesting the Board's authorization to sell its 2001 Ford F-550 4x4 Bucket Truck and 2004

Kubota 72" ZD 28 Zero Turn Mower by online auction at Municibid. The Township has successfully used the Municibid online auction company in the past year to dispose of surplus equipment. Resolution #3, made by Supervisor Robert Birch, seconded by Chairman Joseph Walsh and adopted unanimously, authorized the sale of the Township's 2001 Ford F-550 Bucket Truck and a 2004 Kubota 72" ZTR Mower via online auction, through Municibid.

Director of Fire Services Rick Lesniak reported that Ladder 18 recently experienced significant damage as a result of the drive shaft from the generator failing and striking the housing of the transmission causing two cracks in the transmission housing. Five companies were contacted for estimates to make the necessary repairs. The estimates ranged from \$9,431.24 to \$16,123.44 to replace the damaged transmission with a re-built transmission. New transmission units are not available. Mr. Lesniak recommended that the Board consider the replacement of the transmission as the ladder is expected to serve Montgomery Township for at least the next ten years. Mr. Lesniak reported that staff is recommending the repair be approved for Del-Val International Trucks, Inc. of Montgomeryville to replace the transmission at a cost of \$9,431.24. Resolution #4, made by Supervisor Robert Birch, seconded by Supervisor Candyce Chimera and adopted unanimously, authorized Del-Val International Trucks, Inc. to replace the transmission at a cost of \$9,431.24.

Police Chief Scott Bendig reported that the Police Department had received a grant in 2009 to purchase twelve (12) in-car audio/video recording systems for the police vehicles. It was recently discovered that service/maintenance agreements were never purchased when these systems were installed in 2011. The cost to purchase the service/maintenance agreements is \$3,420.00. As these cameras have been instrumental in presenting airtight cases against a suspect, while also protecting the Department from frivolous lawsuits, it is recommended that the service/maintenance agreements be purchased. Resolution #5, made by Supervisor Michael Fox, seconded by Supervisor Robert Birch and adopted unanimously,

approved the expenditure of \$3,420.00 for the purchase of service/maintenance agreements for the twelve in-car camera systems from CDW-G, under the COSTARS Cooperative Purchasing Program Contract 003-032.

Director of Planning Bruce Shoupe reported that an application for a change of zoning had been received from Terra Vista, LLC, proposing an extension of the Billboard Overlay District on portions of four properties which are located south of Stump Road along southbound Bethlehem Pike. The request is that the Billboard Overlay District be allowed on the southbound side of Bethlehem Pike starting approximately 420 feet south of the centerline of Stump Road for a distance of 990 feet with a depth of 150 feet from the centerline of Bethlehem Pike. Resolution #6, made by Supervisor Michael Fox, seconded by Supervisor Robert Birch and adopted unanimously, set Monday, August 26, 2013, after 8:00 p.m. in the Township building as the date, time and place for a Public Hearing to amend the Zoning Map by extending the Billboard Limited Industrial Overlay District.

Township Manager Lawrence Gregan reported that in 2010, the Montgomery County and Bucks County Planning Commissions had prepared an Act 167 Stormwater Management Plan for the Neshaminy Creek Watershed and had requested municipalities to endorse the adoption of the plan. At that time, Montgomery Township raised an objection to the plan due to the significant financial burden that the plan would impose on Township single family property owners when they tried to construct improvement and/or additions to their homes and properties. As an alternative, the Township recommended that the plan include a "fee-in-lieu-of" (FILO) provision for single family property projects disturbing greater than 1,000 square feet but less than 5,000 square feet. Following several years of negotiations with the two County Planning Commissions and the Pennsylvania Department of Environmental Protection, the Township's persistence has paid off with the inclusion of the Township's recommended "fee-in-lieu-of" (FILO) alternative into the plan. The new language and plan has been reviewed by the

Township Engineer and is now recommended for approval. Resolution #7, made by Supervisor Michael Fox, seconded by Chairman Joseph Walsh and adopted unanimously, endorsed the adoption of the Neshaminy Creek Watershed Act 167 Stormwater Plan as amended with the inclusion of the "Fee-In-Lieu-Of" (FILO) Alternative for Small Projects.

Township Manager Lawrence Gregan reported that in September 2012, the Cutler Group authorized Wolverine Constructors to proceed with certain improvements on Friendship Park. This work involves site grading and paving improvements on the property. The total cost for this scope of improvement to the park is \$513,681.37 and Wolverine Constructors is seeking the ninth and tenth progress payments from the Cutler Group in the amount of \$140,929.50 bringing the total amount paid for the work completed to date to \$411,709.35. The Township Engineer has inspected the site and found the work completed to date to be satisfactory and in accordance with the approved plans. Resolution #8, made by Supervisor Michael Fox, seconded by Supervisor Robert Birch and adopted unanimously, accepted the Engineer's recommendation that the site work being performed at Friendship Park by Wolverine Constructors, has been completed in accordance with the approved plans and specifications and that the Cutler Group be notified of the Township's acceptance so they can proceed with payment to Wolverine in accordance with the provisions of their contract.

Supervisor Michael Fox made a motion to approve the payment of bills. Supervisor Robert Birch seconded the motion. The payment of bills was unanimously approved as submitted.

There being no further business to come before the Board, the meeting adjourned at 9:00 p.m.

Montgomery Township is filled with many talented residents, and this week we would like to honor a number of local students for their outstanding athletic and academic achievements this past year.

Graduating Seniors

- **Chris Melillo** is a recent graduate of La Salle College High School where he graduated with a 3.6 GPA, was a member of LaSalle's National Honor Society and was named an "AP Scholar with Distinction" for his performance on AP exams. Athletically, Chris played varsity baseball for three years at LaSalle where he was pre-season First Team All-State, twice named to the All Catholic Team, twice named to the All City Team and to the All-Southeastern PA team. In 2012, Chris was a starter and leading playoff hitter for LaSalle's AAAA State Champion baseball team and played for the Catholic League in the Carpenter Cup tournament hosted by the Phillies. Chris is a recruited baseball player in the incoming Freshman class for the University of Notre Dame baseball program.
- **Andrew Stone** is a recent graduate of La Salle College High School where he was a 2-time winner of LaSalle's Wesner Art Scholarship and achieved Microsoft Certifications in Server Administration and Security. He won a National A/P Spanish Exam Gold Award and graduated with an overall GPA of 4.15. Andrew competed in Cross Country as well as Indoor and Outdoor Track in which he earned 12 varsity letters and competed in the State Championships all four years. Andrew was on La Salle's 4x800 meter relay team that ran a #1 US time in New York in February and won the Championship of America Distance Medley Relay at this year's Penn relays. Andrew broke 4 all-time school records and has the fastest high school 800 meter run in Pennsylvania this year. Andrew was honored with this year's Dannehower Scholarship Award as the top student-athlete in Montgomery County from nominees representing 27 Montgomery County high schools. He will be attending and running for the University of Notre Dame.

North Penn High School Baseball Team

Further, the North Penn High School Baseball Team played in and won the 2013 PIAA Class AAAA Championship in the title game at Penn State on June 14, 2013. The team beat Lower Dauphin High School 6-5 in a ninth-inning victory. Montgomery Township would like to honor several Montgomery Township team members tonight.

- **David Evan Raymond** played in the position of pitcher for the Championship team and graduated this year as a member of the NPHS class of 2013. David played Varsity baseball for North Penn during both his 11th and 12th grades. Academically, David is an AP student with a 3.93 GPA, and also participated in the 2013 Senior Class Cabinet and Ski and Board Club. David is currently working for Montgomery Township as a camp counselor in their Kids University program and will be attending Penn State University Park- Smeal College of Business in the fall.
- **Jordan Trump** played the position of pitcher for the Championship team and graduated this year as a member of the NPHS class of 2013. Jordan stated that he started playing baseball for Montgomery Township when he was 7 years old and attributes much of his success to his great coaches over the years. Jordan is currently working for Montgomery Township as a camp counselor in their Kids University program, and has done so for the past 4 summers. Jordan will be attending Penn State University in the fall majoring in marketing.
- **Brandon Heggan**, played the position of outfielder for the Championship team and is a member of the NPHS class of 2014. He played Varsity baseball in both his sophomore and junior years as well as soccer in both his freshman and sophomore years, one of only two freshman selected to play on the varsity team. Academically, Brandon is an Honors Student, has maintained straight A's throughout his high school career.
- **Jared Melone** played first baseman for the Championship team as a member of the NPHS class of 2015. 2013 was Jared's first year on the varsity team. In addition to playing baseball, Jared also participates in the Future Business Leaders of America and was the North Penn High School representative to the Montgomery County District Attorney's Leadership Summit in May. Academically, Jared is an Honors Student with a 3.8 GPA.
- **Matt Stella** played the position of backup catcher for the Championship team and is a member of the NPHS Class of 2014. Matt has played baseball for 2 years at North Penn as the starting JV catcher and was brought up to play Varsity during the playoffs. Matt also plays on the North Penn Ice Hockey team and is actively involved in the Future Business Leaders of America. Academically, Matt is an Honors Student at North Penn.
- **Chris Kersey** was the starting shortstop and co-captain for the Championship team and is a member of the NPHS class of 2014. Chris has played varsity baseball for two years for NPHS where he also plays varsity basketball. Chris also plays American Legion Baseball where he was the MVP of the Nor Gwyn Hawks in 2012. Academically, Chris is an Honors Student with a 4.12 GPA.

BACKGROUND:

Mr. Robert Gruber, a resident of Montgomery Township, recently joined the Fire Department of Montgomery Township. Mr. Gruber is being nominated by FDMT to be appointed as a Special Fire Police Officers under the Pennsylvania State Fire Police Statute - Act of 1941, P.L. 137, No. 74, Amended July 11, 1980. P.L. 580, No. 122.

Under this law, before the applicant can perform the duties as a Special Fire Police Officer, the nominated candidate must be confirmed by the Board of Supervisors and sworn in by the Chairman of the Board of Supervisors. Special Fire Police serve the public in the following manner:

- To regulate traffic and keep crowds under control at or in the vicinity of any fire at which their companies are in attendance and to exercise such other police powers as are necessary in order to facilitate and prevent interference with the work of firemen in extinguishing fires.
- To perform their duties when functioning as special fire police at any function, event, or parade conducted by, and under the auspices of any volunteer fire company, or any event, function, or parade conducted by an organization other than a volunteer fire company, providing the request to perform these duties is made by the governing body of the township in which the event will be conducted.
- To perform traffic and or crowd control duties when accidents, floods, or any other emergency requiring performance of such duties until the arrival of proper township police authority or until the emergency no longer exists.

Any person functioning as Special Fire Police Officer and performing a duty under any of the above conditions, shall be deemed to be performing the duties of his/her employment. Fire police performing such duties shall be identifiable by, at minimum, the wearing of a distinctive arm band or hat or uniform or insignia. Under no circumstances does the act grant Special Fire Police the right and / or power to use firearms or other weapons in the exercise of special fire police powers granted under the law.

Mr. Gruber has been interviewed by the Police Department and has been recommended for appointment as a Special Fire Police Officer.

I took a look at the attached comments from your inspector's visit to the General Hancock Townhomes project the night of 6.25.13.

The two lights noted as "rotated 90 degrees" are located in the Costco parking and are not part of the GH townhouse project...they were installed back in the late 1990's as part of Costco shopping center.

The light noted "not on plan" along General Hancock Blvd. was probably installed as part of the Route 202 corridor project by their contractor.....the same applies to the noted light "different light than plan". They are not a part of the GH townhouse project.

The lights noted "off" or "half on" are not part of the townhouse project but we will notify the property management company so they can take care of these two issues.

It appears that all of the lights for the townhouse project are acceptable at least from a night time inspection standpoint. Please let me know when you'll be able to forward the day time inspection notes, if any, so we can address them quickly.

Please be advised that on April 29, May 1, 2, 6, 9, 14, 16, 17, 30, and June 12 and 20 of 2013, I conducted inspections of plant material within the General Hancock Townhomes site in accordance with the approved Landscape Plan prepared by Schlosser & Clauss dated November 26, 2008 and last revised August 6, 2010 and the approved Landscaping Field Change Sheets dated June 17, 2011.

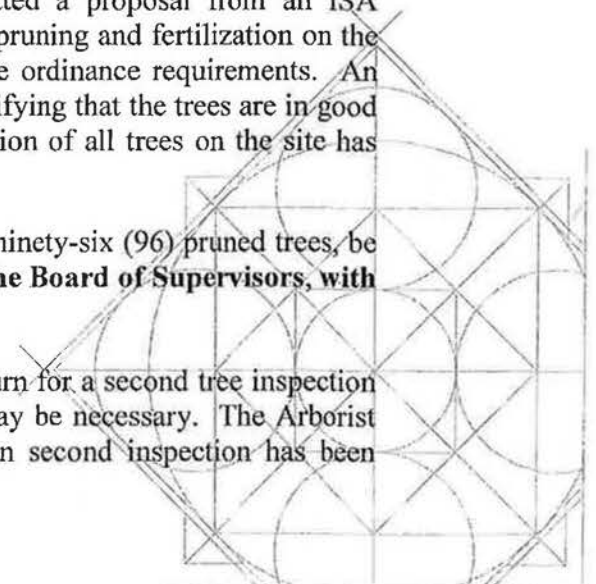
All landscape material on the site has been found to be acceptable to begin the maintenance period, with the following exception:

During the course of the landscape inspections, ninety-six (96) Red Maple and White Ash were found to have pruned leaders. In accordance with both the tree planting detail shown in SLDO Chapter 205 Appendix C, as well as the tree planting detail on Sheet No. 22 of 27 of the approved plan set, the leaders of trees are not to be cut.

The Developer and Landscape Contractor have submitted a proposal from an ISA certified Arborist for restoration pruning and have begun pruning and fertilization on the ninety-six (96) Ash and Maple trees that do not meet the ordinance requirements. An additional letter from the Arborist has been submitted certifying that the trees are in good condition following the first round of pruning. Fertilization of all trees on the site has been completed.

We recommend that all landscape material, including the ninety-six (96) pruned trees, be accepted into the maintenance period **upon approval by the Board of Supervisors, with the following requirements:**

- In September 2014 the Arborist should return for a second tree inspection and perform any additional pruning that may be necessary. The Arborist must notify the Township in writing when second inspection has been



completed, if any additional structural pruning has been completed, and whether the trees are in a healthy and acceptable condition. If the letter is not received, the trees will not be accepted for the End of Maintenance.

- At the time of the End of Maintenance inspection, if the trees do not meet the ordinance requirement of possessing a healthy central leader, the trees should be required to be replaced.

Dear David King:

Per your request I visited the General Hancock Townhomes in Montgomery Township, PA to inspect approximately 100 newly installed ash (*fraxinus*) and maples (*acer*). I have also taken time to review the report submitted by Valerie L. Liggett of Boucher and James Inc. From what I understand in the report, there are many issues revealed but most importantly to you are the issues surrounding the previous pruning of the landscape nursery stock prior to installation. With regards to that pruning it appears that the terminal bud as well as many of the lateral scaffold branches were internodally pruned on many of the specimens. The concern with this kind of pruning is that the stock does not meet township requirements of having a defined single terminal bud and that it will affect the overall structural development of the trees. It also suggests that the "severely pruned" trees will be "vulnerable to infections" and "weak branch attachment".

While in essence these statements are true, the landscape nursery stock is of such a young age that it is still very possible for the trees to re-establish terminal buds as well as flourish with well-balanced crowns. That being said it would not happen without mitigation via corrective pruning and fertilization to stimulate new growth and improve the overall health and vigor of the trees.

The pruning and fertilization should be performed in accordance with ANSI A-300 standards. The pruning should be "structure" pruning with a focus on eliminating the internodal cuts and re-establishing a terminal leader and balanced crown. The fertilizer should be a slow release fertilizer with an NPK ratio of 3-1-1 and should be soil injected into the root systems of the trees. The pruning should be inspected after two growing seasons (September of 2014 or 18 months from March of 2013) to ensure the trees are growing correctly and if necessary re-pruned to encourage proper growth. It is in my opinion that if these steps are taken that the trees will recover and fulfill the requirements of the township.
