IMPORTANT INFORMATION:

- All permits for permanent places of amusement shall expire on the 31st day of December next succeeding the date upon which they are issued, unless sooner suspended, surrendered or revoked for cause by the proper authorities of Montgomery Township.
- Permits for temporary places of amusement or for forms of itinerant amusement shall expire at the time specified therein. The producer of an itinerant form of amusement shall notify the Business Tax Administrator promptly of any change in the original contemplated itinerary, either as to the date or time of the conduct of the amusement at each place.
- It is imperative that your business contact the Planning and Zoning Department to determine what additional permitting and application fees are required of your business to be in full compliance with the Township's statutes. They can be reached at 215-393-6920.
- Applications should be properly and completely filled out, signed and dated. Incomplete applications will be returned to sender.
