4. LATE FEES:
 - A. INTEREST IS CHARGED AT THE RATE OF 1% PER MONTH OF THE TAX DUE FROM THE DATE THE TAX IS DUE.
 - B. AN ADDITIONAL 10% PENALTY OF THE TAX DUE IS CHARGED IF A RETURN IS NOT FILED WITHIN 30 DAYS OF THE DATE DUE.

ANY ENTITY CONDUCTING ANY PLACE OF "AMUSEMENT", WHERE THE GENERAL PUBLIC, OR A LIMITED OR SELECTED NUMBER MAY, UPON PAYMENT OF AN ESTABLISHED PRICE, ATTEND OR ENGAGE IN ANY AMUSEMENT MUST APPLY FOR AN AMUSEMENT PERMIT AND PAY THE APPROPRIATE FEE. SEE TAX ORDINANCE FOR DETAILS.
