Our services include fire standby for rehabilitation and safety, emergent medical care and transport of the sick and injured residents and visitors of your municipality.

When called upon, our organization also provides medical standby for public presentations and outreach.

During the month of **December 2019**, our service responded to 156 calls for service in your municipality. Of this total, 108 were transported to local hospitals. The breakdown of these transports are as follows:
