The 2020 Reorganizational meeting and regular quarterly meeting of the Montgomery Township Community & Recreation Center (Mont CRC) Advisory Committee were held on Wednesday February 12th at the Montgomery Township Community and Recreation Center. Reorganization Meeting for 2020

Call to Order: The 2019 Reorganizational meeting of the Mont CRC Advisory Committee was called to order by temporary chair Tony Ruggieri at 6:36pm.

Temporary chair Ruggieri opened the floor for nominations for the 2020 Committee Chair. A motion was made by Mr. Gaylord to nominate Tom Alesi as Chair. The motion was seconded by Ms. Lynch. There was no opposition.

On a motion by Mr. Alesi and a second by Mr. Ruggieri, Marcy Lynch was nominated as Vice Chair of the Advisory Committee. The vote electing Marcy Lynch, Vice Chair, was unanimous.
