TIPS FOR TESTIFYING

The following suggestions may help you when you are ready to testify at trial as a witness for the prosecution:

- Review the facts of the case in your mind before you are called to testify. Don't be afraid to say that you are unable to remember something.
- Be courteous and respectful to the judge and the attorneys, even during cross examination.
- Dress neatly and appropriately.
- Be yourself.
- Listen carefully and answer only the question being asked. If you don't understand a question, ask for an explanation.
- An attorney may object to a question, so wait until the judge rules on the objection before you answer.
- Don't volunteer information, and don't give your personal opinions unless you are asked to do so.
- Don't guess, and never make up an answer if you are not sure. It is better to say "I don't know" or "I don't remember."
- Don't talk to other victims or witnesses about your testimony.

CONFIDENTIALITY

The Victim/Witness Unit will keep your information confidential, but victims must keep in mind that anything you say that could affect the criminal case might be shared with the Assistant DA assigned.

THE MEDIA

You don't have to speak to the media about what happened to you if you don't want to. The Victim/ Witness Unit staff can help shield you from the media if you wish and will support your decision, but we can't address them on your behalf.

GRIEVANCES

You have the right to file a complaint if your rights as a victim have been violated. If your complaint can't be resolved in a timely manner by the DA's Office, you may contact the Office of the Victim Advocate at the PA Commission on Crime and Delinquency.





RESPONSIBILITIES OF CRIME VICTIMS

- To provide a valid address and telephone number and to provide timely notice of any changes in the status of such information to police and the DA's Office.
- To provide any other required information to all agencies responsible for providing information and notification to the victim.
- To submit Restitution Forms that are truthful and honest and include copies of all bills, receipts and estimates.
- To provide updated restitution information if the original amounts submitted to the DA's Office change.
- 5. To maintain a neat appearance, proper dress and appropriate demeanor respectful of the Court.
- 6. To ALWAYS tell the truth.

Crime Victims Have Rights!

BASIC BILL OF RIGHTS
FOR VICTIMS IN PENNSYLVANIA
Act 155 of 1992

The right to be told...

- about basic services available to you
- about certain court events, including information on bail, escape of offender, release of an offender
- about the details of the final disposition of a case

The right to receive...

- notice of the arrest of the offender
- information about restitution and assistance with compensation
- accompaniment to all criminal proceedings by a family member, a victim advocate or support person

The right to provide input...

- into the sentencing decision and to receive help in preparing an oral and or/ written victim impact statement decisions
- into post-sentencing decisions

HOW TO ENROLL TO BE NOTIFIED OF AN INMATE'S RELEASE FROM CUSTODY

The PA-SAVIN Program (Statewide Automated Victim Information and Notification) can notify you by telephone and/or e-mail of any changes in the custody status of a county or state inmate.

- For a county inmate: call the Victim/Witness Unit at 610-278-3144 or enroll 24/7 by calling 866-9PA-SAVIN (866-972-7284) or go online to **www.pacrimevictims.com** and click on "Notifications."
- For a state inmate: call the Office of the the Victim Advocate at 800-332-4472 or 800-563-6399 or TDD 877-349-1064 or contact PA-SAVIN as mentioned above.

RECOVERING YOUR LOSSES

Restitution

As part of the sentence, the judge can order the offender to pay restitution to you, based on information you provide. If restitution is not ordered, you may want to talk to a private attorney about filing a civil suit.

Crime victims will be mailed a Restitution Form asking for detailed information about stolen or damaged property, medical, dental, counseling or medication bills, or funeral expenses you had as a result of the crime. There will also be information about writing an impact statement to the judge about how the crime has affected you and those around you. Complete the form and return it to the Victim/Witness Unit in a timely manner. If you have questions, contact the Restitution Coordinator in the Adult Division at 610-278-2928 or in the Juvenile Division at 610-630-2252, ext. 3024.

VICTIMS' COMPENSATION ASSISTANCE PROGRAM

This program eases the financial impact of a crime on victims and their families. You may be eligible for financial help for various expenses: medical and counseling bills, lost wages, loss of support, relocation, funeral, crime scene cleanup and in some cases, stolen cash.

You can file a VCAP claim in several different ways...

- Contact the Adult or Juvenile Victim/Witness Unit in the District Attorney's Office as mentioned above under "Restitution."
- Contact an advocate at the appropriate community-based agency as referred to by the Victim/Witness Unit.
